Information Obligation

Pursuant to Article 13(1) and (2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC, as well as the Act on the Protection of Personal Data of 10 May 2018 and the Act of 27 June 1997 on Libraries (Journal of Laws No. 85, item 539, as amended), we inform you that the controller of personal data is the Municipal Public Library in Raszyn, ul. Poniatowskiego 20, 05-090 Raszyn.

The controller has appointed a Data Protection Officer, contact: e-mail: iodo@bibliotekaraszyn.pl. Your personal data are processed solely for purposes related to the statutory activities of the library, in particular: providing access to library materials, statistics, debt recovery. Providing personal data is voluntary, but necessary in order to use the library's resources. Personal data are stored for the period during which the user uses the library collections and are deleted 5 years after the reader's last visit, provided that all liabilities towards the library have been settled. Data are protected against unauthorized access by third parties and will be disclosed only to entities authorized under applicable law. You have the right to request from the controller: access to your data, updating and rectification, data portability, restriction of processing, objection to further processing. In disputed matters, you have the right to lodge a complaint with the supervisory authority.

Consent for Simplified Registration Procedure (MAK+ system)
